# NOTICE OF SETTLEMENT OF THE RETROFOAM CLASS ACTION

This Notice may affect your rights. Please read carefully.

### PURPOSE OF THIS NOTICE

This notice is directed to Class Members who owned or had an interest in real property in Ontario when RetroFoam was injected or installed into the property and who applied to the ecoEnergy Retrofit-Homes Program.

On August 12, 2015, the settlement was approved by a judge of the Ontario Superior Court of Justice. The defendants will pay the sum of \$13,000,000 in full and final settlement of all claims in return for a release and a dismissal of the class action.

### SUMMARY OF THE SETTLEMENT TERMS

After the payment of all court-approved expenses, a fund of approximately \$7,612,000 will be divided equally among all property owners who submit a claim for compensation that is approved by the Administrator.

If there is more than one owner for a property injected with RetroFoam, the cheque will be payable to the owners provided all owners are living at the same address. If all owners are not living at the same address, each owner will be sent an equal share of the amount payable to their individual addresses.

All claims for compensation must be accompanied by supporting documentation and must be approved by the Administrator. In some cases, disputes about compensation will be settled by the Arbitrator. Any settlement cheques that remain uncashed after six months will be paid to the Access to Justice Fund operated by the Law Foundation.

### HOW TO MAKE YOUR CLAIM FOR COMPENSATION?

Detailed instructions for submitting your claim are available at www.retrofoamclassaction.com

You must deliver your completed claim with supporting documentation to the Administrator on or before December 1, 2015 in order to be eligible to receive compensation. If you do not submit a completed claim form on or before December 1, 2015, you will **not** be eligible to receive any settlement funds.

The Administrator will communicate directly with you about the outcome of your claim for compensation.
